**BE IT RESOLVED** by the Forsyth County Board of Commissioners that the Chairman or County Manager and the Clerk to the Board are hereby authorized to execute, on behalf of Forsyth County, an agreement for the benefit of its Department of Public Health, to receive grant funds in the amount of \$603,350 from the North Carolina Department of Health and Human Services, Division of Public Health, Women's and Children's Health Section, Children and Youth Branch, to support the Nurse-Family Partnership Program (NFP Program) in order to improve child and maternal health, reduce child abuse and neglect, reduce crime and increase school readiness, subject to a pre-audit certificate thereon, by the County Chief Financial Officer if applicable, and approval as to form and legality by the County Attorney.

**EXPLANATION:**

The Department of Public Health has been awarded \$603,350.00 in additional funding from the Department of Health and Human Services, Division of Public Health, Women's and Children's Health Section, Children and Youth Branch to support the Nurse-Family Partnership Program (NFP Program) which improves child and maternal health, reduces child abuse and neglect, reduces crime and increases school readiness. The funding period for these funds is June 1, 2017 through May 31, 2018.

The additional \$603,350 in recurring grant funds will support seven staff positions in the Nurse Family Partnership Program.
